**GENERAL ORDER NO. 3**

AN ORDER TO EFFECT THE INTEGRATION INTO THE CODE OF CONDUCT OF THE BANGSAMORO ISLAMIC ARMED FORCES (BIAF), THE TOTAL BAN ON ANTI-PERSONNEL MINES AND FOR COOPERATION OF MINE ACTION PURSUANT TO THE DEED OF COMMITMENT SIGNED BY THE MORO ISLAMIC LIBERATION FRONT (MILF) UNDER GENEVA CALL AND FOR OTHER PURPOSE.

(PANGANDAAKAN SA HADJE-HADJE UMBUL TELLU (3))

Pangandaakan subey tahinang pinalamud si aturan sarah paghinang weh Bangsamoro Islamic Armed Forces (BIAF), ye sa hadje-hadje panegesan si kemon gey makajari magtanem pagpalettup bomba duk kapagdambuwaan gah niya makajari magpaleppa bomba si kapana-ayun si meh bakas kapagjanjian, kapimahan weh MILF si diyawaan kapangalingan lahat GENEVA duk meh saddi pe maksud.

The General Staff (GS) as the highest policy and decision making body of the Bangsamoro Islamic Armed forces (BIAF), Moro Islamic Liberation Front (MILF) have come up with a decision to integrate into the BIAF Code of Conduct, the following:

Kanakuraan mahadjehin, si alen sa Langkew-Langkew hal pagnakurah duk maghihinang bak tulun si meh (BIAF), MILF kapagtaallukan matengge siye pikilan atawa baktulan weh subey tatibuuk si aturan sarah paghinang weh BIAF meh ininen:

SECTION I. Title – this order shall be known as Total Ban on Anti-Personnel (AP) Mines and for Cooperation in Mine Action”.

BAHAGIAN DAMBUWA (1) – Gellalnen – “ye pangandaakan inin subey hinati weh sa hadje-hadje pamgesan ye magpalettup bombahin duk subey magtaayun gey mausah magpalettup mina diyata bulak”.

SECTION 2 . Definition of terms –(a) By Anti-Personnel Mines we refer to those devices which effectively explore by the presence, proximity of contact of a person, including other victim-activated explosive devices an anti-vehicles mines with the same effect whether with or without anti-handling devices.

(b) By total ban, we refer to a complete prohibition on all use, development, production, acquisition, stockpiling, retention, and transfer of such mines, under any circumstances.

BAHANGIAN SI KADUWE (2)- Maana Hurup – (a) Gey makajari magpalettup minitiin atawa bombahin, hinati weh kami ye ne kemon kapanyapan hap pagbustak nen sabab kasabu, katumapit meh aa ye kamura paghinati de, lamud meh saddi pe tabinsana weh pagpabustakin duk ye pagpabustak para si sasakatan salih du niyah atawa gah niyah panyap lamud taantan.

(b) Pamegesan Mahadjehin, - tartantu ye si kemon-kemon sasukuh pamegesan amban pagpahap, pangahinang, pangeddo, pamondo, pangennah, pangalibbi duk palatun si sasuku ne mina atawa bomba pagpalettup diyawaan si ine-ine kahalalan.

SECTION 3. Prohibited Acts – Its shall be prohibited to an BIAF members to own, posses, keep, use, manufacture, stockpile, utilize, victim-activated, anti-personnel (AP) mines and other victim-activated explosive anywhere and at all time.

BAHAGIAN SI KATELLU (3) Hinang pamegesan- Subey teed pamegesan si kemon lamud si BIAF, magdapuh, ngennah, ngangguna, ngahinang, mondo, ngosal, ye pagpalettup makabinsah duk saddi pe makabinsanah pinabustak antag-antag ne lahat duk si kemon waktu.

SECTION 4. Duty and Responsibility – it shall be the duty and responsibility of any person to report immediately to any BIAF officer the presence of Victim-Activated explosive anywhere or everywhere found or located . the concern BIAF shall immediately report the discovery or presence of the said banned item(s) or explosive(s) to the Base Command concern, who in turn, shall communicate the matter to the General Staff within five (5) days thereafter for appropriate action. The General Staff shall insure that the item(s) or explosive(s) discovered shall be properly secured and taken cared of for security reason and other purposes in line with Geneva Call Deed of Commitment.

BAHAGIAN SI KAAMPAT (4) – Hinang duk kapatutan- Subey hinanang duk kapatutan si sine-sine aa ye magsumbungin atawa mangakahin pusi sine sine Nakura BIAF bang niyah bomba atawa pagpabustak ye makabinsana si mahadjana si antag-antag ne palaihan ne atawa pabetaran ne. Nakura BIAF bakas pangakahanin subey ye magtuy mag-aka weh niya lai kasuwah ye ne bomba niyaan atawa pagpabustakin tudju meh kanakuraan mahadjehin (General Staff) si diyalem lime (5) ellew puwas amban pakasangka de aka ley supaya kahinangan pikilan atawa baktulan. Ye kanakuraan mahadjehin subey tantu de meh panyap pagpabustakin taaka duk takasuwah ley duk subey taeddoh hinatul duk taparihara pahap para si kasanyangan duk saddi pe maksud ye tumaayun si pangandaakan/pangalingan ye meh bakas kapagdambuwaan si lahat Geneva.

SECTION 5. Penalty – a Fine of three thousand (3,000.00) pesos or a penalty of suspension from service for a period of three months, in case of first offence; and a fine of five thousand (5,000.00) pesos or a penalty of suspension from service for a period of five (5)

months for second offenses; and a fine of five thousand (5,000.00) pesos or dismissal from service for third offenses shall be imposed, or both at the discretion of the General Staff.

BA HAGIAN SI KALIME(5) MULTA – Minultahan tellu ngibu pilak (3,000.00) atawa multa pinahali amban tinang ne dahuh si diyalem tellum (3) bulan bang kaniyaan nen makahinang kasaan mintedde duk multa lime ngibu (5,000.00) atawa minultahan pinalahi amban hinang ne si diyalem lemembulan (5); si kaduwe iye makalanggal kasaan; duk multa nen lime ngibu (5,000.00) duk isab atawa pinatahala ne teed ye amban hinang ne si katellu ne iye maka hinang kasaan, sartah subey ne teed pinaniyah multa pe duk pinatahala ne iye malaingkan nen si atas tempat pikil kanakuraan ne mahadjehin atawa malangkewin.

SECTION 6. Effectivity- This order shall take effect immediately upon approval.

BAHAGIAN SI KAENNEM (6) Panagnaan- Pangandaakan inin subey ye magtagnah magtuey bang ne iye kataalluan weh nakurain.
